LEARN TO SKATE WARNING AND NOTICE

SKATING HAZARDS- Ice skating (particularly in Learn to Skate classes) is a potentially hazardous activity. (Participants in the Learn to Skate Program assume all risk of dangers associated with, or incident to, ice skating, including, but not limited to colliding or falling down, or into the ice rink doors or entry ways, rink boards, rink supports, benches or bleachers: tripping or falling, or having skates caught on, or in holes, cracks, or rough surfaces in or on the ice surface, rink boards, rink doors or areas of ingress or degrees into the rink.

INSURANCE- No form of insurance is provided to or for participants in this program.

SKATING SURFACE (ICE)- Due to time and budgetary constraints, and the great number of varied ice related activities, the Arena cannot guarantee that the ice surface is free from standing water, holes, cracks, rough spots, or soft spots either on the surface or along the boards. Participants assume the risk of the forgoing conditions.

DUTY OF INSPECTION- Each participant has the responsibility to inspect the ice, goals, boards, and bench areas (to include doors) before each activity, or other use of the rink ice, in order to familiarize himself or herself to the existing ice conditions. Any defects should be immediately brought to the attention of appropriate Arena personnel.

PROHIBITONS- Participants are prohibited from “racing”, “roughhousing” or any conduct which endangers persons or property. Participants are prohibited from participating in Learn to Skate while under the influence of drugs or alcohol.

PARTICIPATION EQUIPMENT- Except for rental skates, each participant is responsible for the amount, kind, make and quality of personal skating equipment worn by the participant.

***Throughout this document “Arena” means Ben Boeke, Dempsey Anderson Ice Arenas, SMG Facility Management of Alaska, Inc., and the Municipality of Anchorage, both individually, severally and collectively and includes officers, employees, and agents of the forgoing organizations.
